Expansion Update – Duncan has been working on the expansion activities with Ecora the inventory consultants. Draft analysis AAC projections (old & new CF licence area) should be received by May 1st.

Harvest Update – Duncan gave harvest update. CP4 blocks 15 and 27 south of Tumbler Ridge are complete. Deactivation activities are planned in the spring. The sawlog volume harvested was 16,970m³ vs the budgeted figure of 17,202m³. In addition, 2,500m³ of pulp logs were delivered to the Taylor pulp mill from these two blocks.

Investment Update – Rob from RBC Investments called in and gave update in closed meeting.



Planting 2020/2021 – Duncan gave planting update. Due to a nursery issue seedling for 2020 spring plant would not be available. The planned seedings for 2020 were 51,000seedlings. These seedlings will be grown for 2021 spring planting season. The 2021 season planting is planned for 167,000 trees including a few Larch and Douglas -fir for research purposes.

- Policy Review Policy review amendment of Policy 1 Director Code of Conduct, was reviewed and unanimously approved. Procedure 03, Procedures for Director Accountability Agreement was tabled. Steve Tory made motion for Procedure 03 review to be tabled next meeting. Al Kangas 2nd.
