2024 Activities

- Harvested 14 of the16 2024 planned blocks to date.
- Surveyed 10 blocks All were satisfactory stocked
- Zero NSR on community forest as of 2024
- Conuma land extraction Negotiated \$60,000 paid.
- Approx 45 ha affected 848 m3 mature volume 2,028 m3 immature
- MOT in discussions for gravel expansion on gravel pit south of Tumbler
- No planting program in 2025.
- Ordered 771,286 seedling for spring plant 2026.
- Looking into requesting a grade 4 credit for pulp harvested in 2024.
- as per section 17(6) of the cut control regulation.
- On target to meet cut control.
- Plan to identify 150,000m3 of new harvest blocks.
- Reported to CRA Aug 2024 for year end.
- Plan to move logging tax period back to calendar year.
- Negotiated log purchase rate considerably better than budget for 2024 summer and 2025 winter season.
- CP5 terminates Dec 2026.

Log Purchase Agreement

- Log purchase agreement for wither Contract is \$.79 greater than last contract. \$30,000 more revenue than last contract.
- Gross revenue planned for W2025 estimated at \$1,730,000

Dividend paid to shareholder

On advice of KPMG TRCF paid the district a dividend of \$24,208.
 KPMG has recommended this dividend to be paid to the shareholder. This dividend to the shareholder allows TRCF to minimize corporate taxes in 2024.

Corp/LP

 A subcommittee has been formed between the District and TRCF to evaluate the change to an LP structure proposed by KPMG

Bridge assets

 As part of the Summer 2024 log purchase agreement TRCF was awarded two bridges from West Fraser valued at \$189,500

FSP extension

 The TRCF Forest Stewardship Plan has been renewed to October 2027

New Forest License document

 A replacement Forest Licence has been renewed and will be reviewed again in 2031

Grants 2024

Grant total of \$33,878 was given to eight recipients in 2024
